- 4. Financial Review: Board approved the Independent Financial Review by Levy, Erlanger and Co.
- 5. Landscape Committee: There are 7 projects that need to be done. The first priority will be the water line break in irrigation lines under the driveway at 2241. The other 6 properties involve sod removal, stump grinding, improve soil, plant kurapia ground cover, installing pavers where needed, etc. Bill Spicer quoted each separately, but overall may be less expensive if multiples are done at the same time. Gloria and Ann to discuss reserve monies allotted for this project and putting renovations on the upcoming year's reserve study for those that cannot be done this year.
- 6. Owner Satisfaction Survey in Next Newsletter? Questions were posed; the board will look at the possible survey questions and decide if they will include this with a newsletter. Other newsletter items discussed were parking, owner's maintenance of backyard fruit trees to avoid pests, board position recruitment, web-site reminders, and upcoming landscape renovations.
