PARKING RULES

Owner and renters, if you are not familiar with our rules and regulations about parking, please contact any board member for a copy of the Parking Rule which clarifies the CC&R's parking restrictions.

Each house was furnished with a green laminated parking permit for use when visitors are parking in your driveway or in any of the parking spots, **any time** between the hours of 12:00am midnight and 5:00 am. If you have out-of-town guests for longer than 3 nights in a row, please request a yellow variance pass from a board member.

Here are some typical misunderstandings about parking:

Question: Why did my guest get a ticket when they were not spending the night? They were only parked in my driveway until 12:30 am!

Answer: ANY car parked, for ANY amount of time between the hours of 12:00-midnight and 5:00am will be ticketed UNLESS it has a valid permit.

Question: What about a party? I may have several guests staying late.

Answer: Call any board member, in advance, to request yellow variance passes for your guests. Also, please remember to keep it quiet after 10:00 pm.

Please understand that CC&R violation fines are \$50 per occurrence. Why risk it?

HOA ASSOCIATION BOARD MEETINGS

The board of directors conducts quarterly membership meetings each year. The open Board Meetings will be held on the first Wednesdays of March, June, September, and December at 6:30 pm. The location will be announced on a flyer, which will be posted on the gates 3-5 days before the meeting.

Our next open meeting will be **June 5, 2013 at 6:30pm**. We invite our residents to attend these meetings to know what is going on in our community and to bring any concerns they may have about existing problems.

Occasionally, there will be an executive session meeting posted that is not open to the association at large. These meetings are for the purpose of discussing possible CC&R violations for specific properties. If you have any questions regarding these or any other matters, please contact any board member.

OUR FRONT GATES

Out exit gate is getting old. It receives 25% more activity than does the incoming gate because of something called "corner cutting". This happens when people entering the property don't wait until the gate is completely open before driving in and making a quick turn to the left. This tight turn triggers the exit gate to open. Replacement of the gate arm is scheduled for next year. In the meantime, please wait for the gate to open fully before driving in. Reflective dots have been placed on the pavement to help guide cars in the right direction and reduce excessive wear on the exit gate.

LANDSCAPE AND ARCHITECTURE

According to the CC&R's, any resident who wishes to add a structure or embellishment to the front of their property, must first receive written approval of the HOA Board. Also, residents are not permitted to change or remove any plantings in front of their homes without approval. If you are not satisfied with what has been planted or unhappy about the condition of the plants,
